Die Staatslughaweregulasies, 1963, soos afgekondig by Goewermentskennisgewing R. 1974 van 20 Desember 1963, en soos gewysig,* word hierby soos volg verder gewysig:

Regulasie 40 (3) (a) word gewysig deur die woorde "tien sent" deur die uitdrukking "20c" te vervang.

STATE AIRPORT REGULATIONS, 1963

The Minister of Transport has, in terms of section 22 of the Aviation Act, 1962 (Act 74 of 1962), as amended, made the regulations contained in the Schedule hereto.

SCHEDULE 13

The State Airport Regulations, 1963, as promulgated under Government Notice R. 1974 of 20 December 1963, and as amended,* are hereby further amended as follows:

Regulation 40 (3) (a) is amended by the substitution for the words "ten cents" of the expression "20c".
