Act No. 12, 1979

SUBDIVISION OF AGRICULTURAL LAND
AMENDMENT ACT, 1979.

GENERAL EXPLANATORY NOTE:

Words underlined with solid line indicate insertions in existing enactments.

ACT

To amend the Subdivision of Agricultural Land Act, 1970, so as to further regulate control regarding the sale or grant of rights in respect of a portion of agricultural land, and to provide for matters connected therewith; and to validate the establishment and enlargement of the areas of jurisdiction of certain authorities.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 70 of 1970, as amended by section 1 of Act 55 of 1972 and section 1 of Act 18 of 1977.

1. Section 1 of the Subdivision of Agricultural Land Act, 1970 (hereinafter referred to as the principal Act), is hereby amended 5 by the insertion after the definition of "agricultural land" of the following definition:

"'building' means any building erected or used for any purpose whatsoever, and includes any other structure, whether of a temporary or permanent nature and 10 irrespective of the materials used in the erection thereof, so erected or used;".

Amendment of section 3 of Act 70 of 1970, as substituted by section 3 of Act 18 of 1977.

2. Section 3 of the principal Act is hereby amended by the substitution for paragraph (e) of the following paragraph:

"(e) no portion of agricultural land, whether surveyed or not, 15 and whether there is any building thereon or not, shall be sold or advertised for sale, and no right to such portion shall be sold or granted for a period of more than 10 years or for the natural life of any person or to the same person for periods aggregating more than 10 20 years, or advertised for sale or with a view to any such granting;".

Validation of certain action in respect of agricultural land.

3. The—

- (a) establishment of the Public Health Area of Roode Krans by the Administrator of the Province of Natal by 25 Proclamation No. 218 of 1972 on the agricultural land mentioned in the Schedule to that Proclamation;
- (b) enlargement of the area of jurisdiction of the Verwoerdburg Town Council by the Administrator of the Province of Transvaal by Administrator's Notice 269 of 21 30 February 1973 so as to include the agricultural land described in Schedules A and B to that Notice; and
- (c) enlargement of the area of jurisdiction of the White River Town Council by the Administrator of the Province of Transvaal by Administrator's Notice 715 of 35

Tot wysiging van die Wet op die Onderverdeling van Landbougrond, 1970, ten einde beheer oor die verkoop of verlening van regte ten opsigte van 'n deel van landbougrond verder te reël, en voorsiening te maak vir aangeleenthede wat daarmee in verband staan; en om die instelling en uitbreiding van sekere instansies se regsgebiede geldig te maak.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op die Onderverdeling van Landbou-
5 grond, 1970 (hieronder die Hoofwet genoem), word hierby
gewysig deur na die omskrywing van „adverteer” die volgende
omskrywing in te voeg:
 „gebou enige gebou wat vir enige doel hoegenaamd opgerig
 10 is of gebruik word, en ook enige ander struktuur, hetsy

 as 10 jaar verleen word nie, of vir verkoop of met die
 oog op enige sodanige verlening geadverteer word
 nie;”.

**SUBDIVISION OF AGRICULTURAL LAND
AMENDMENT ACT, 1979.**

15 June 1977 so as to include the agricultural land described in the Schedule to that Notice, shall be deemed to have been done with the consent in writing of the Minister of Agriculture under section 4 (2) of the principal Act. 5

Short title.

4. This Act shall be called the Subdivision of Agricultural Land Amendment Act, 1979.
