Die Minister van Statistiek het kragtens artikel 17 van die Wet op Statistieke, 1976 (Wet 66 van 1976), gelees met Goewermentskennisgewing R. 139 van 4 Februarie 1977, die regulasies in die Bylae hiervan met betrekking tot die jaarlikse versameling van statistieke aangaande skofwerk ten opsigte van fabriekswese-inringings, uitgevaardig.

REGULATIONS IN TERMS OF SECTION 17 OF THE STATISTICS ACT, 1976 (ACT 66 OF 1976)

SHIFTWORK IN MANUFACTURING, 1979

The Minister of Statistics has, in terms of section 17 of the Statistics Act, 1976 (Act 66 of 1976), read with Government Notice R. 139 of 4 February 1977, made the regulations in the Schedule hereto in connection with the annual collection of statistics on shiftwork in manufacturing establishments.

BYLAE

1. In hierdie regulasie, tensy uit die samehang anders blyk, beteken—

(1) "fabriekswese-inrigting"—

(a) enige perseel wat gebruik word vir of in verband met—

(i) die vervaardiging, verwerking, maak, voorbereiding of verpakking van goedere of artikels;

(ii) die slag van lewende hawe, met inbegrip van pluimvee en kleinwild; en

(iii) installerings-, monterings-, voltooiings-, herstel- en ander werk;

(b) enige perseel waarin administratiewe, klerklike, verkoops-, navorsings- of ander werksaamhede verrig word wat regstreeks in verband staan met werksaamhede in paragraaf (a) genoem;

(2) "persoon in beheer van 'n fabriekswese-inrigting"—

(a) iemand wat gedurende die tydperk in regulasie 3 omskryf, die eienaar van sodanige inrigting was of iemand was aan wie die eienaar toesig of beheer oor, of die administrasie, leiding of bestuur van die inrigting, na gelang van die geval, oorgedra het;

(b) 'n trustee of likwidateur of eksekuteur of administrateur van 'n insolvente of bestorwe boedel of 'n likwidateur van 'n maatskappy of vereniging sonder winsoogmerk, of 'n koöperatiewe vereniging of maatskappy in likwidasie, of 'n geregtelike bestuurder van 'n maatskappy onder geregtelike bestuur, welke boedel of maatskappy of vereniging of koöperatiewe vereniging of maatskappy gedurende die tydperk in regulasie 3 omskryf, die eienaar van sodanige inrigting was.

2. Die persoon in beheer van 'n fabriekswese-inrigting moet, nadat hy deur die Sekretaris van Statistiek daartoe versoek is, voor of op 30 November 1979 of voor of op sodanige latere datum as wat die Sekretaris van Statistiek om goeie redes kan bepaal, 'n opgawe wat by die Sekretaris van Statistiek verkrygbaar is, indien, waarin al die besonderhede of inligting voorgeskryf in regulasie 4, vir die tydperk in regulasie 3 omskryf, verstrek word.

3. Die tydperk wat deur die opgawe gedek moet word, is die laaste volle week van Oktober 1979, dit wil sê die sewe dae wat strek van Sondag, 21 Oktober 1979 tot Saterdag, 27 Oktober 1979.

4. Die volgende besonderhede en inligting moet ooreenkomstig die bepalings van hierdie regulasies in die opgawe verstrek word:

(1) Besonderhede van die getal produksie- en verwante werkers werksaam op 'n multiskofbasis gedurende die week 21 tot 27 Oktober 1979, en die duur van die verskillende skofte.

(2) Besonderhede van die getal produksie- en verwante werkers nie werksaam op 'n multiskofbasis gedurende die week 21 tot 27 Oktober 1979 nie, en die duur van die werksdae.

(3) Of dit tegnies moontlik is om meer skofte met die huidige vaste bates in te stel, al dan nie, en indien nie, die beraamde bedrag van addisionele investering ten opsigte van installasies en uitrusting ten einde die instelling van meer skofte te bewerkstellig.

(4) Of dit ekonomies geregverdig is om meer skofte in te stel, al dan nie.

SCHEDULE

1. In these regulations, unless the context otherwise indicates—

(1) "manufacturing establishment" means—

(a) any premises used for or in connection with—

(i) the manufacture, processing, making, preparing or packing of goods or commodities;

(ii) the slaughtering of livestock, including poultry and small game; and

(iii) installation, assembly, completion, repair and other work;

(b) any premises in which administrative, clerical, sales, research and other activities directly related to any activity mentioned in paragraph (a) are performed;

(2) "person in charge of a manufacturing establishment" means—

(a) any person who, during the period defined in regulation 3, owned such an establishment or any person who was charged by such owner with the supervision, control, administration, direction or management, as the case may be, of the affairs or such an establishment;

(b) a trustee or liquidator or executor or administrator of an insolvent or deceased estate, or liquidator of a company or a non-profit society or a co-operative society or company in liquidation, or a judicial manager of a company under judicial management, which estate or company or society or co-operative society or company owned such establishment during the period defined in regulation 3.

2. The person in charge of a manufacturing establishment shall, after having been requested thereto by the Secretary for Statistics, on or before 30 November 1979 or on or before such later date as the Secretary for Statistics may for good cause allow, render a return which is obtainable from the Secretary for Statistics, furnishing all the particulars or information prescribed in regulation 4 hereof, for the period prescribed in regulation 3.

3. The period to be covered by the return shall be the last full week of October 1979, that is the seven days from Sunday, 21 October 1979, to Saturday, 27 October 1979.

4. The following particulars and information shall be furnished in the return according to the provisions of these regulations:

(1) Particulars of the number of production and related workers working on a multi-shift basis during the week 21 to 27 October 1979, and the duration of the different shifts.
