BYLAE

Woordomskrywings

1. (1) In hierdie Proklamasie beteken "Algemene Proklamasie" die Proklamasie op die Oordrag van Uitvoerende Gesag (Algemene Bepalings), 1977 (Proklamasie AG 7 van 1977).

(2) Die uitdrukking "beampte" in die Algemene Proklamasie beteken, by die toepassing van daardie Proklamasie met betrekking tot hierdie Proklamasie, 'n offisier soos omskryf in artikel 1 van die Polisiewet, 1958 (Wet 7 van 1958).

(3) By die toepassing van die Algemene Proklamasie met betrekking tot hierdie Proklamasie, word hierdie Proklamasie geag 'n oordragproklamasie te wees soos in artikel 1 van genoemde Algemene Proklamasie omskryf.

(4) 'n Verwysing in hierdie Proklamasie na 'n bepaalde wet word uitgelê as 'n verwysing ook na 'n regulasie, reël of ander maatreël wat kragtens daardie wet gemaak is of daarop betrekking het.

TRANSFER OF THE ADMINISTRATION OF THE SOUTH AFRICAN POLICE TO THE ADMINISTRATOR-GENERAL

Under the powers vested in me by section 38 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), I hereby make the laws set out in the Schedule.

Given under my Hand and the Seal of the Republic of South Africa at Pretoria this Twenty-eighth day of August, One thousand Nine hundred and Eighty.

SCHEDULE

Definitions

1. (1) In this Proclamation "General Proclamation" means the Executive Powers Transfer (General Provisions) Proclamation, 1977 (Proclamation AG. 7 of 1977).

(2) The expression "officer" in the General Proclamation means, for the purpose of the application of that Proclamation in relation to this Proclamation, an officer as defined in section 1 of the Police Act, 1958 (Act 7 of 1958).

(3) For the purpose of the application of the General Proclamation in relation to this Proclamation, this Proclamation shall be deemed to be a transfer proclamation as defined in section 1 of the said General Proclamation.

(4) A reference in this Proclamation to any particular law, shall be construed as including a reference to a regulation, rule or other enactment made under or relating to that law.

Transfer of the administration of the South African Police

2. Notwithstanding anything to the contrary contained in any other law but subject to the provisions of this Proclamation and the General Proclamation, the administration of the affairs of the Territory of South

Toepassing van wette

3. (1) Die bepalings van subartikel (1) van artikel 3 van die Algemene Proklamasie is, sonder om afbreuk te doen aan die bepalings van subartikel (2) van daardie artikel, nie van toepassing nie op—

(a) 'n verwysing na die Minister van Polisie of die Staatspresident of die *Staatskoerant* in die Polisiewet, 1958 (Wet 7 van 1958), behalwe die verwysing na genoemde Minister in artikels 4 en 32 van daardie Wet vir sover daardie artikels in verband staan met die werksaamhede van die Suid-Afrikaanse Polisie in die gebied ingevolge artikel 5 van daardie Wet of 'n ander wet maar met die uitsondering van die werksaamhede wat met betrekking tot paragraaf (a) van genoemde artikel 5 gewoonlik deur die tak van die Suid-Afrikaanse Polisie bekend as die Veiligheidstak verrig word;

(b) daardie bepalings van die Wet op Wapens en Ammunisie, 1969 (Wet 75 van 1969), wat betrekking het op die invoer in of uitvoer uit die Republiek, soos in daardie Wet omskryf, van wapens en ammunisie, soos aldus omskryf.

(2) Die uitdrukking "Staatspresident" waar dit die eerste keer voorkom in artikel 7 (1) van die Polisiewet, 1958, beteken, vir sover daardie artikel betrekking het op die gebruik van die Suid-Afrikaanse Polisie in die gebied, ook die Administrateur-generaal.

Finansiële reëlings

4. (1) Ten opsigte van die boekjaar wat op 31 Maart 1981 eindig, word daar uit die Staatsinkomstefonds, in die paaientemente wat die Tesourie van die Republiek bepaal, in die Sentrale Inkomstefonds van die gebied gestort die bedrag, soos deur die Kommissaris van die Suid-Afrikaanse Polisie met die instemming van genoemde Tesourie bepaal, waarvoor daar in die begrotingspos van uitgawes van die Suid-Afrikaanse Polisie uit die Staatsinkomstefonds vir daardie boekjaar voorsiening gemaak is met die oog op die besteding daarvan ten opsigte van die administrasie in of ten opsigte van die gebied, van die bepalings van 'n wet wat ingevolge hierdie Proklamasie deur die Administrateur-generaal behartig word of onder sy gesag geskied, en wat nie aldus bestee is of bestee sal word nie.

(2) Die bedrag ingevolge subartikel (1) in genoemde Sentrale Inkomstefonds gestort, word geag ingevolge die wette op die onttrekking van geld uit daardie Fonds, ten opsigte van die boekjaar wat op 31 Maart 1981 eindig, bewillig te wees vir die bestyding van die uitgawes in verband met die administrasie in of ten opsigte van die gebied van die bepalings in subartikel (1) bedoel, waarvoor voorsiening gemaak word in 'n begroting van uitgawes deur die Kommissaris van die Suid-Afrikaanse Polisie aan die Administrateur-generaal voorgelê en deur die Administrateur-generaal, na oorlegpleging met die rekenpligtige beampte bedoel in artikel 15 van die Skatkis- en Ouditwet, 1975 (Wet 66 van 1975), soos in die gebied toegepas, goedgekeur.

(3) Enige uitgawes in verband met die administrasie in of ten opsigte van die gebied, van 'n bepaling van 'n wet wat betrekking het op 'n aangeleentheid in artikel 2 van hierdie Proklamasie bedoel, wat nie ingevolge hierdie Proklamasie deur die Administrateur-generaal

West Africa in relation to any matter which at the commencement of this Proclamation is administered by the Minister of Police of the Republic, shall be carried on by the Administrator-General.

Application of laws

3. (1) The provisions of subsection (1) of section 3 of the General Proclamation shall, without detracting from the provisions of subsection (2) of that section, not apply to—

(a) any reference to the Minister of Police or the State President or the *Government Gazette* in the Police Act, 1958 (Act 7 of 1958), except the reference to the said Minister in sections 4 and 32 of that Act in so far as those sections are connected with the functions of the South African Police in the Territory in terms of section 5 of that Act or any other law but excluding such functions as may in relation to paragraph (a) of the said section 5 ordinarily be performed by the branch of the South African Police known as the Security Branch;

(b) those provisions of the Arms and Ammunition Act, 1969 (Act 75 of 1969), that relate to the importation into or exportation out of the Republic, as defined in that Act, of arms and ammunition, as so defined.

(2) The expression "State President", where it occurs for the first time in section 7 (1) of the Police Act, 1958, includes, in so far as that section relates to the employment of the South African Police in the Territory, the Administrator-General.

Financial arrangements

4. (1) In respect of the financial year ending on 31 March 1981 there shall be paid from the State Revenue Fund, in such instalments as may be determined by the Treasury of the Republic, into the Central Revenue Fund of the Territory the amount, as determined by the Commissioner of the South African Police with the concurrence of the said Treasury, which has been provided for in the vote of expenditure of the South African Police from the State Revenue Fund for that financial year with the object of spending it in respect of the administration, in or in respect of the Territory, of the provisions of any law which is carried on by the Administrator-General or takes place under his authority, and has not been or will not be so spent.

(2) The amount paid into the said Central Revenue Fund in terms of subsection (1), shall be deemed to have been appropriated, in terms of the laws governing the withdrawal of money from that Fund, in respect of the financial year ending 31 March 1981 for the defrayal of such expenditure in connection with the administration in or in respect of the Territory, of the provisions referred to in subsection (1), as may be provided for in an estimate of expenditure submitted by the Commissioner of the South African Police to the Administrator-General and approved by the Administrator-General after consultation with the accounting officer referred to in section 15 of the Exchequer and Audit Act, 1975 (Act 66 of 1975), as applied in the Territory.

(3) Any expenditure in connection with the administration in or in respect of the Territory, of a provision of any law relating to any matter referred to in section 2 of this Proclamation, which is not administered by the Administrator-General in terms of this Proclamation,
