REGULASIES

Die Minister van Finansies het kragtens artikel 13 van die Wet op die Staatstenderraad, 1968 (Wet 86 van 1968), die regulasies in die Bylae hiervan uitgevaardig.

BYLAE

1. In hierdie regulasies beteken "die Wet" die Wet op die Staatstenderraad, 1968 (Wet 86 van 1968), en het enige uitdrukking waaraan 'n betekenis in die Wet toegeken is, daardie betekenis, en, tensy uit die samehang anders blyk, beteken—

"aanbod" enige aanbod, met inbegrip van 'n tender of prysnotering deur 'n persoon binne of buite die Republiek, om 'n ooreenkoms bedoel in artikel 4 (1) (a) van die Wet aan te gaan;

"beperking" 'n beperking wat aan 'n persoon opgelê word en voortspruit uit 'n beslissing van die Raad in regulasie 3 (7) (a) bedoel;

"kontrakteur" enige natuurlike of regspersoon of liggaam van persone van wie 'n aanbod deur die Staat aangeneem is;

"Republiek" die Republiek van Suid-Afrika;

"Voorsitter" die Voorsitter van die Staatstenderraad aangewys ooreenkomsartikel 3 (2) van die Wet.

2. Behoudens die bepalings van 'n wet van die Parlement, mag leweransies en dienste vir en namens die Staat, die huur of verhuur van enigiets of die verkryging of verlening van enige reg vir en namens die Staat en die vervreemding van roerende Staatsgoed slegs deur bemiddeling van die Raad verkry, gereel of vervreem word.

BEVOEGDHEDE VAN DIE RAAD

3. (1) Die Raad is, behoudens die bepalings van enige ander Parlements-wet, kragtens artikel 4 van die Wet bevoeg om leweransies en dienste vir die Staat te verkry, die huur of verhuur van enigiets of die verkryging of verlening van enige reg vir of namens die Staat te reël en roerende Staatsgoed te vervreem.

DEPARTMENT OF FINANCE

No. R. 139

REGULATIONS

The Minister of Finance has, in terms of section 13 of the State Tender Board Act, 1968 (Act 86 of 1968), made the regulations contained in the Schedule hereto.

SCHEDULE

1. In these regulations "the Act" means the State Tender Board Act, 1968 (Act 86 of 1968), and any expression to which a meaning has been assigned in the Act, shall bear such meaning, and, unless inconsistent with the context—

"Chairman" means the Chairman of the State Tender Board appointed in terms of section 3 (2) of the Act;

"contractor" means any natural or legal person or body of persons from whom an offer has been accepted by the State;

"offer" means any offer, including a tender or quotation by a person within or outside the Republic, for concluding an agreement referred to in section 4 (1) (a) of the Act;

"Republic" means the Republic of South Africa;

"restriction" means a restriction imposed on any person and which arises from a decision of the Board referred to in regulation 3 (7) (a).

2. Subject to the provisions of any act of Parliament, supplies and services for and on behalf of the State, the hiring or letting of anything or the acquisition or granting of any right for and on behalf of the State and the disposal of movable State property may only be procured, arranged or disposed of through the Board.

POWERS OF THE BOARD

3. (1) The Board is, subject to the provision of any other Act of Parliament, empowered in terms of section 4 of the Act to obtain supplies and services for the State, to arrange the hiring or letting of anything or the acquisition or granting of any right for or on behalf of the State, and to dispose of movable State property.

(2) Nieteenstaande die bepalings van subregulasie (1) kan die Raad kragtens artikel 4 (3) van die Wet, met die goedkeuring van die Minister in elke geval, en op die voorwaardes wat die Minister goedkeur, met inbegrip van voorwaardes aangaande vergoeding (as daar is), 'n bevoegdheid wat die Raad ingevolge die Wet vir en namens die Staat kan uitoefen, vir en namens enige liggaaam uitoefen wat by of kragtens wet ingestel is.

(3) Die Raad kan, behoudens die bepalings van enige ander Parlements-wet, voorskrifte in verband met die verkryging van leweransies en dienste, die huur of verhuur van enigets, of die verkryging of verlening van enige reg en die vervreemding van roerende Staatsgoed aan staatsdepartemente uitrek ten einde die doelstellings van die Wet te verwesenlik.

(4) Die Raad kan deskundige advies inwin en kan enige beampete of werknemer in die Staatsdiens versoek om deskundige of tegniese advies te gee waar dit vir sodanige beampete of werknemer wettiglik gemoorloof is om aan die Raad die verlangde advies te gee.

(5) Die Raad kan enige beampete of werknemer in diens van 'n staatsdepartement of enige ander organisasie wat verteenwoordiging in die Raad het, aanwys as gekoöpteerde lid van die Raad om in die tydelike afwesigheid van 'n lid die staatsdepartement of ander organisasie te verteenwoordig: Met dien verstande dat sodanige gekoöpteerde lid nie geregtig is om oor 'n saak in besprekking te stem nie.

(6) Die Raad kan *post facto*-goedkeuring verleen aan die optrede van 'n staatsdepartement waardeur 'n bevoegdheid wat by die Wet of hierdie Regulasies aan die Raad verleen is, uitgeoefen is, indien die Raad tevrede is dat sodanige optrede van die staatsdepartement in omstandighede van nood of andersins in die beste belang van die Staat geskied het, mits die versuum van die staatsdepartement om die voorgeskrewe procedures te volg nie aan nataligheid te wye is en die Staat nie as gevolg daarvan skade gely het nie.

(7) (a) Indien die Raad van oordeel is dat 'n persoon—

(i) sy aanbod gewysig of teruggetrek het na die sluitingstyd dog voordat hy van die aanvaarding daarvan in kennis gestel is; of

(ii) versuum het om binne die tydperk in die tender-voorwaardes bepaal of sodanige langer tydperk as wat die Raad toegelaat het, 'n kontrak te onderteken of sekerheid te stel wanneer dit van hom vereis is; of

(iii) in gebreke bly of gebly het om enige van die voorwaardes van 'n kontrak na te kom, of 'n kontrak op 'n onbevredigende wyse uitvoer of uitgevoer het; of

(iv) omkoopvoordeel beloof, aangebied of gegee het, of op bedrieglike wyse of te kwader trou of op 'n ander onbehoorlike wyse opgetree het;

kan die Raad, benewens enige ander regsmiddel waaroor hy beskik, beslis dat gedurende die tydperk wat hy bepaal, geen aanbod van die betrokke persoon oorweeg word nie.

(b) Die Raad kan 'n beperking te eniger tyd ophef of wysig.

(c) Enige beperking deur die Raad aan 'n persoon opgelaai, kan na goedvinde van die Raad ook van toepassing gemaak word op enige ander onderneming, vennoot, bestuurder, direkteur of ander persoon wat geheel of gedeeltelik beheer oor die onderneming van eersbedoelde persoon uitoefen of uitgeoefen het of kan uitoefen en waarmee of met wie die eersbedoelde persoon aktief geassosieer is of was.

(2) Notwithstanding the provisions of subregulation (1), the Board may, in terms of section 4 (3) of the Act, with the approval of the Minister in each case and on such conditions, including conditions regarding compensation (if any), as the Minister may approve, exercise any power which the Board may in terms of the Act exercise for and on behalf of the State, for and on behalf of any body established by or under any law.

(3) The Board may, subject to the provisions of any other Act of Parliament, issue directives to Government departments in regard to the procurement of supplies and services, the hiring or letting of anything, or the acquisitioning or granting of any right, and the disposal of movable Government property in order to achieve the objects of the Act.

(4) The Board may invite expert advice and may call upon any officer or employee in the Public Service to provide expert or technical advice in so far as it is for such officer or employee legally admissible to provide such advice to the Board.

(5) The Board may appoint any officer or employee in the employ of a Government department or any other organisation represented on the Board as a co-opted member of the Board to represent in the temporary absence of a member, the Government department or other organisation: Provided that such co-opted member shall not be entitled to vote on a matter under discussion.

(6) The Board may approve *post facto* the action of a Government department whereby any power bestowed upon the Board by the Act or these Regulations has been exercised if the Board is satisfied that the action of such department took place in circumstances of emergency or otherwise was in the best interests of the State, provided that the failure of such department to follow prescribed procedures cannot be attributed to negligence and that the State has not suffered a loss as a result thereof.

(7) (a) If the Board is of opinion that a person—

(i) has amended or withdrawn his offer after the closing time but before he has been notified of its acceptance; or

(ii) has failed to sign a contract or to provide security within the period stipulated in the conditions of tender or such extended period as the Board may allow, when required to do so; or

(iii) fails or has failed to comply with any of the conditions of a contract or executes or has executed a contract unsatisfactorily; or

(iv) has promised, offered or given a bribe, acted fraudulently or in bad faith or in any improper manner;

the Board may, in addition to any other legal remedies it may have, resolve that no offer from the person concerned should be considered during a period it may stipulate.

(b) The Board may at any time rescind or vary a restriction.

(c) Any restriction imposed by the Board on any person may at the discretion of the Board also be made applicable to any other enterprise, partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person and with which or with whom the first-mentioned person is or was actively associated.

(d) By die toepassing van hierdie subregulasie sluit die uitdrukking "persoon", in verband met enige beperking, ook 'n werknemer of agent van so 'n persoon in.

(e) Waar die Raad 'n beperking met betrekking tot die oorweging van 'n aanbod ople, of so 'n beperking wysig of ophef, moet hy die Spoorwegtenderraad, die Tenderade van die Provinciale Administrasies, die Tenderade van die Administrasie van Suidwes-Afrika, enige ander tenderade waarop besluit mag word, staatsdepartemente en, waar nodig, die Republiek se buitelandse verteenwoordigers, van enige besluit met betrekking tot sodanige beperking of opheffing of wysiging daarvan in kennis stel en genoemde rade, departemente en verteenwoordigers versoek om soortgelyke stappe te doen.

(f) Waar enige van die rade in subregulasie (e) genoem, 'n beperking met betrekking tot die oorweging van aanbiedinge ople, kan die Raad eweneens 'n soortgelyke beperking aan die betrokke persoon ople.

PROCEDURE OP VERGADERINGS

4. (1) Die Raad vergader by sodanige tussenpose en by sodanige spesiale geleenthede as wat bepaal word deur die Voorsitter of, in sy afwesigheid, die Vice-voorsitter of, in die afwesigheid van beide, die lid wat die aanwesige lede van die Raad uit hul midde kies soos in artikel 3 (2) van die Wet bedoel, en enige vergadering aldus belê, kan verdaag of uitgestel word deur die Voorsitter, Vice-voorsitter of sodanige verkose lid, na gelang van die geval.

(2) Vyf lede maak 'n kworum vir 'n vergadering van die Raad uit.

(3) (a) Behoudens die bepalings van die Wet en hierdie regulasies, is 'n lid van die Raad wat teenwoordig is by 'n vergadering, verplig om sy stem uit te bring ten opsigte van 'n aangeleentheid wat tot stemming gebring is en waaroor die betrokke lid wettiglik 'n stem kan uitbring.

(b) In die geval van 'n staking van stemme op 'n vergadering van die Raad het die Voorsitter van die vergadering 'n beraadslagende sowel as 'n beslissende stem.

(c) Die getal stemme vir of teen enige besluit moet in die notule aangedui word indien die vergadering so beslis. Enige lid kan eis dat sy stem insgelyks genotuleer word.

(4) By die oorweging van 'n saak wat 'n staatsdepartement of 'n ander organisasie raak wat in die Raad verteenwoordig word, is die lid van sodanige departement of organisasie nie geregtig om oor die betrokke saak te stem nie.

(5) Die Voorsitter van 'n vergadering kan enige saak terugtrek voordat daaroor gestem is.

(6) Alle besprekings op vergaderings van die Raad en alle sake wat oorweeg en besluite wat geneem word deur die Raad, word as vertroulik behandel en mag nie deur 'n lid of gekoöpteerde lid van die Raad, of 'n beampete, werknemer of enige persoon van wie verlang word om deskundige advies aan die Raad te gee soos bedoel in regulasie 3 (4), openbaar gemaak word sonder dat die toestemming van die Raad vooraf verkry en in die notule opgeteken is nie.

(d) For the purpose of this subregulation the term "person", in respect of any restriction, also includes an employee or agent of such person.

(e) Where the Board imposes a restriction regarding the consideration of an offer, or varies or rescinds such restriction, it shall inform the Railway Tender Board, Provincial Tender Boards, the South-West Africa Administration Tender Board, any other tender boards decided upon, Government departments and, where necessary, the Republic's representatives abroad, of any resolution relative to such restriction or rescindment or variation thereof and request the said boards, departments and representatives to take similar steps.

(f) Where any of the boards mentioned in subregulation (e) imposes a restriction relative to the consideration of offers the Board may likewise impose a similar restriction on the person concerned.

PROCEDURE AT MEETINGS

4. (1) The Board shall meet at such intervals and on such special occasions as may be determined by the Chairman or, in his absence, by the Vice-Chairman or, in the absence of both, by the member who has been elected by the members present from their number as contemplated in section 3 (2) of the Act, and any meeting thus convened may be adjourned or postponed by the Chairman, Vice-Chairman or elected member, as the case may be.

(2) Five members shall constitute a quorum for a meeting of the Board.

(3) (a) Subject to the provisions of the Act and these regulations, any member of the Board present at a meeting is obliged to cast a vote in respect of any matter which is being put to the vote and in respect of which the member concerned may legally cast a vote.

(b) In the event of an equality of votes at a meeting of the Board the Chairman of the meeting shall have a casting vote as well as a deliberative vote.

(c) The number of members voting for or against any resolution shall be entered in the minutes if so decided by the meeting. Any member may demand that his vote be likewise recorded.

(4) When a matter affecting a Government department or other organisation represented on the Board is under consideration the member of such department or organisation shall not be entitled to vote on the matter under discussion.

(5) The Chairman of a meeting may withdraw any matter before it has been put to the vote.

(6) All discussions at Board meetings and matters considered and decisions arrived at by the Board shall be treated as confidential and shall not be disclosed by any member or co-opted member of the Board, or an officer, employee or any other person invited to provide expert advice to the Board as referred to in regulation 3 (4) unless the prior approval of the Board has been granted and recorded in the minutes.

BESLUISTE VAN DIE RAAD

5. (1) Wanneer aanbiedinge op uitnodiging van die Raad ingedien word met die doel om 'n ooreenkoms bedoel in artikel 4 (1) (a) van die Wet aan te gaan—

(a) is die Raad nie verplig om die laagste of enigste aanbod aan te neem nie;

(b) kan die Raad, in 'n geval waar 'n aanbod op meer as een item betrekking het, sodanige aanbod ten opsigte van enige bepaalde item of items aanneem;

(c) kan die Raad enige aanbod aanneem ongeag die feit dat sodanige aanbod nie as gevolg van sodanige tenderuitnodiging gedoen is nie of nie voldoen aan die tendervooraardes wat in sodanige uitnodiging uiteengesit is nie.

(2) Enige besluit van die Raad in verband met die toekenning van 'n kontrak is finaal en die Raad hoof ingevolge artikel 4 (1) (d) van die Wet geen rede te verstrek vir die aanvaarding of verwering van 'n bepaalde aanbod nie.

OORDRA VAN BESLUISTE VAN DIE RAAD

6. Besluite van die Raad word aan die betrokkenes meegedeel deur beampies en werknemers aangewys ingevolge artikel 12 van die Wet, of deur die lid of lede van die Raad wat die Raad aanwys.

AANSTELLING VAN KOMITEES DEUR DIE RAAD

7. (1) In die geval van 'n komitee deur die Raad ingevolge artikel 5 (1) van die Wet aangestel, maak 'n meerderheid van die lede van sodanige komitee 'n kworum uit.

(2) Die bepalings van regulasies 4 (3) (a), 4 (3) (c), 4 (5), 4 (6) en 6 is *mutatis mutandis* op 'n komitee van die Raad van toepassing.

(3) In geval van 'n staking van stemme op enige vergadering van 'n komitee, moet die saak wat oorweeg word na die Raad verwys word vir uitsluitsel.

VOORKEUR

8. By die oorweging van die toekenning van kontrakte kan die Raad, ten opsigte van goedere in die Republiek geproduseer, vervaardig of gemonteer, of ten opsigte van goedere wat in enige ander klas val, voorkeur toestaan op die basis wat die Minister van tyd tot tyd bepaal.

OPLEGGING VAN 'N GELDBOETE WAAR 'N OOREENKOMS AANGEWAAN IS OP GROND VAN ONJUISTE INLIGTING DEUR DIE TENDERAR VERSTREK

9. Indien 'n kontrak toegeken is aan 'n kontrakteur op grond van inligting deur hom verstrek ten opsigte waarvan daar na die sluiting van bedoelde ooreenkoms bewys word dat dit onjuiste inligting was, kan die Raad, benewens enige ander regsmiddel waaroor hy beskik—

(a) op die kontrakteur alle onkoste, verliese of skade verhaal wat die Staat as gevolg van die toekenning van die kontrak gehad het of gely het; en/of

(b) die kontrak opsê en enige skade verhaal wat die Staat mag ly deur daarna minder gunstige reëlings te moet tref; en/of

(c) die kontrakteur 'n boete van hoogstens 5 persent van die waarde van die kontrak ople.

10. Goewermentskennisgewing R. 1733 van 27 September 1968 word hierby ingetrek.

DECISIONS OF THE BOARD

5. (1) When, at the invitation of the Board, offers are submitted for the purpose of concluding an agreement referred to in section 4 (1) (a) of the Act, the Board—

(a) is not obliged to accept the lowest or any offer;

(b) may, where an offer relates to more than one item, accept such offer in respect of any one or more specific items;

(c) may accept any offer notwithstanding the fact that such offer was not made in response to such tender invitation or does not comply with the tender conditions set out in such invitation.

(2) Any decision by the Board regarding the award of a contract shall be final and the Board shall in terms of section 4 (1) (d) of the Act not be obliged to give any reason for the acceptance or rejection of a particular offer.

CONVEYANCE OF DECISIONS OF THE BOARD

6. Decisions of the Board are conveyed to the persons concerned by officers and employees appointed in terms of section 12 of the Act, or by the member or members of the Board designated by the Board.

APPOINTMENT OF COMMITTEES BY THE BOARD

7. (1) In the case of a committee appointed by the Board in terms of section 5 (1) of the Act, the majority of the members of such committee shall constitute a quorum.

(2) The provisions of regulations 4 (3) (a), 4 (3) (c), 4 (5), 4 (6) and 6 shall apply *mutatis mutandis* to a committee of the Board.

(3) In the event of an equality of votes at any meeting of a committee the matter under consideration shall be referred to the Board for a decision.

PREFERENCE

8. When considering the award of contracts, the Board may accord a preference in respect of goods produced, manufactured or assembled in the Republic, or in respect of goods falling into any other category, on the basis determined by the Minister from time to time.

IMPOSITION OF A MONETARY PENALTY WHERE AN AGREEMENT IS CONCLUDED ON THE STRENGTH OF INCORRECT INFORMATION FURNISHED BY THE TENDERER

9. If a contract is awarded to any contractor on the strength of information furnished by him in respect of which it is after the conclusion of such agreement proved that such information was incorrect the Board may, in addition to any other legal remedy it may have—

(a) recover from the contractor all costs, losses or damages incurred or sustained by the State as a result of the award of the contract; and/or

(b) cancel the contract and recover any damages which the State may suffer by having to make less favourable arrangements after such cancellation; and/or

(c) impose on the contractor a penalty not exceeding 5 per cent of the value of the contract.

10. Government Notice R. 1733 of 27 September 1968 is hereby withdrawn.

AMENDMENT OF RULES (No. DAR/33)

Under section 120 of the Customs and Excise Act, 1964, the Schedule to the rules published in Government Notice R. 1771 of 5 October 1973 is amended by—

the substitution in paragraph 7 under the heading "Cape Town General." for the existing particulars of the following:

1. Main Gates, Dock Road.
2. North Gate, Portswood Road.
3. Heerengracht Gate.
4. Pirow Street Gate.*
5. Paardeneiland Gate.

* *Note.*—This gate is open on weekdays only, except public holidays, as follows:

Monday to Friday, from 07h00 to 18h00.
Saturday, from 07h00 to 14h00.”

CUSTOMS AND EXCISE ACT, 1964

DETERMINATIONS OF TARIFF CLASSIFICATION AND FURNISHING THEREOF ON BILLS OF ENTRY (LIST TAR/22)

1. The following determinations are published in terms of section 47 (9) of the Customs and Excise Act, 1964 (Act 91 of 1964).

2. In terms of section 39 (1) (c) of the aforementioned Act, importers are required to furnish the determination number on bills of entry at the time of entry of such goods.

D. ODENDAL, Commissioner for Customs and Excise.

Notes

1. The description of the goods is given for determination purposes only and should not be construed as correct, complete or binding for any other purpose.

2. Goods which are packed for or put up for retail sale are in all instances classified under the appropriate tariff subheading where such provision exists.

3. Tariff subheadings which depend upon the mass, dimensions, form, value, packing, etc., of goods are not necessarily indicated.

SCHEDULE

1. In these Regulations, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Dried Fruit Scheme, published by Proclamation R. 302 of 1962, as amended, shall have a corresponding meaning and—

"dried fruit" means fruit as defined in Part B of Schedule I of the Agricultural Produce Agency Sales Act, Act 12 of 1975, in its original or a processed form which has been subjected to any recognised drying process whereby the greater part of its moisture has been extracted; and

"month" means the period extending from the first to the last day, both days inclusive, of any of the 12 months of a year.

2. A general levy on dried fruit imposed in terms of section 46A of the Marketing Act, 1968, shall subject to the provisions of regulation 3, be paid to the Department of Agriculture and Fisheries, Private Bag X250, Pretoria, 0001—

(a) in the case of sales of dried fruit by the producer thereof, monthly within 15 days after the last day of the month in which he has sold that dried fruit; and

(b) in the case of sales of dried fruit by any other person on behalf of the producer thereof, within 15 days after the last day of the month in which the last quantity of dried fruit, delivered to such a person for sale, has been sold.

3. Except for payments made by the Board each payment of a general levy shall be accompanied by a statement indicating the quantity of dried fruit sold during the month concerned or the quantity of dried fruit received by producers thereof for sale as well as the average price at which such quantity have been sold.

(b) in the case of a sale by any other person on behalf of the producer thereof, be 0,02 per cent of the gross value of such dried fruit:

Provided that fractions of a cent shall be adjusted to the ensuing full cent.

(2) For the purposes of subclause (1) the gross value of dried fruit shall be deemed equal to the amount due to a producer thereof by the person through whom such dried fruit has been sold, in respect of the sale of such dried fruit.

4. In each case where the general levy is payable by any person other than the producer of the dried fruit in respect of which the general levy is payable, such other person may recover the amount of the general levy by deducting it from the amount due to the producer in respect of the sale of such dried fruit.

(c) amend Government Notice R. 1063 of 26 May 1978 (as applied by Government Notice R. 1516 of 21 July 1978), as amended by Government Notices R. 1210 of 8 June 1979 (as applied by Government Notice R. 1823 of 24 August 1979) and R. 282 of 15 February 1980 (as applied by Government Notice R. 904 of 2 May 1980) by—

(i) the substitution for the trade "Diesel-elektrotechniese passer" of the trade "Diesel-elektriese passer" in the Afrikaans text of paragraph (ii); and

(ii) the substitution for clause 2 of the Conditions of the following clause:

"2. Period of apprenticeship

(a) Subject to subclauses (b) and (c) the period of apprenticeship shall be four years in all designated trades.

(b) The period of apprenticeship of an apprentice who, whether prior to or during his apprenticeship, has rendered continuous service in terms of the Defence Act, 1957 (Act 44 of 1957), shall be reduced by a period of not more than—

(i) eight months of a first period of 24 months or longer; or

(ii) six months of a first period of 18 months; or

(iii) four months of a first period of 12 months; and

(iv) 30 days of any subsequent period; of such service.

(c) Notwithstanding the provisions of subclause (b), an apprentice shall not be entitled to a reduction in his period of apprenticeship under subclause (b) (iv) of more than 90 days in respect of military service rendered prior to his apprenticeship.

(d) Any reduction in the period of apprenticeship in terms of subclauses (b) and (c) shall operate with effect from the date upon which the apprentice commences his apprenticeship, or resumes his apprenticeship after returning from service in terms of the Defence Act, 1957.

(e) The employer of an apprentice referred to in subclause (b) shall, within seven days of the departure of the apprentice on service in terms of the Defence Act, 1957, notify the Secretary of the Committee of such departure and, likewise, within seven days after the apprentice returns from such service."; and

(d) determine that the Conditions set out in paragraph (c) above shall, from the date of prescription thereof, also apply to apprentices who are employed in any trade which is or was a designated trade in the undertaking and area in respect of which the Railway Apprenticeship Committee was established.

The State President has been pleased, under section 33 of the Police Act, 1958 (Act 7 of 1958), to approve the following amendments to the Regulations for the South African Police, as published under Government Notice R. 203 in *Government Gazette Extraordinary* 719 (Regulation Gazette 299) of 14 February 1964, and subsequently amended.

Regulation 1.—Substitute the following for the definition of "superior" in subregulation (1) (XXXVII):

"superior" means, in addition to a superior in rank, any member, who, irrespective of seniority in service or rank, has command or exercises authority over another member."

Regulation 15.—Add the following paragraph after subregulation (1) (e):

"(f) on account of misconduct."

Schedules.—Substitute the following for Schedules D and E:

"SCHEDULE D

ALLOWANCES

WHITE MEMBERS

(Referred to in regulation 21)

Pensionable allowances

White constables who have served for a period of not less than 10 years and to whom the 'POLICE GOOD SERVICE MEDAL' or 'THE SOUTH AFRICAN POLICE MEDAL FOR FAITHFUL SERVICE' has been awarded shall, in addition to their substantive pay, be paid a pensionable allowance of R40 per annum: Provided that—

(i) the allowance shall be paid only in respect of one of the aforesaid medals awarded, and that, should the award of such medal be cancelled or annulled or should such medal be declared forfeited, the allowance shall also be forfeited;

(ii) with effect from 1 February 1951, satisfactory service in the former Police Force of the Borough of Durban shall be regarded as qualifying service for the grant of the allowance.

SCHEDULE E

ALLOWANCES

NON-WHITE MEMBERS

(Referred to in regulation 21)

Pensionable allowances

Non-White constables who have served for not less than 10 years and to whom the 'POLICE GOOD SERVICE MEDAL' or 'THE SOUTH AFRICAN POLICE MEDAL FOR FAITHFUL SERVICE' has been awarded shall, in addition to their substantive pay, be paid a pensionable allowance of R30 per annum in the case of Indians and Coloureds and R24 per annum in the case of Blacks: Provided that the allowance shall be paid only in respect of one of the aforesaid medals and that, should the award of such medal be cancelled or annulled or should such medal be declared forfeited, the allowance shall also be forfeited."
