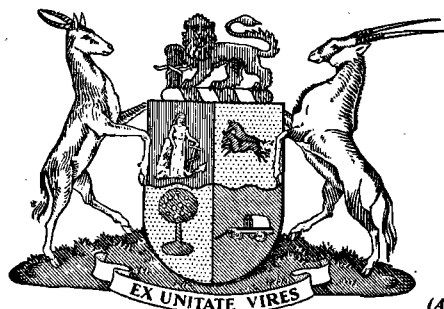

**GOEWERMENSKENNISGEWING.**

**DEPARTEMENT VAN BINNELANDSE SAKE.**

No. R. 337.] [6 Maart 1964.]

DIE WET OP VREEMDELINGE, 1937.

**REGULASIES.**

Hierby word bekendgemaak dat dit die Staatspresident behaag het om, kragtens die bevoegdheid hom verleen by artikel *elf* van die Wet op Vreemdelinge, 1937 (Wet No. 1 van 1937), soos gewysig, onderstaande regulasies uit te vaardig ter vervanging van die regulasies afgekondig by Goewermentskennisgewing No. 161 van 30 Januarie 1937, soos gewysig by Goewermentskennisgewing No. 281 van 17 Februarie 1937, No. 466 van 17 Maart 1938, No. 455 van 28 Maart 1939, No. 1975 van 20 Desember 1957, No. 1049 van 10 November 1961 en No. 1483 van 14 September 1962, en die regulasies afgekondig by Goewermentskennisgewing No. 759 van 11 Mei 1937, soos gewysig by Goewermentskennisgewing No. 1030 van 16 Junie 1938 en No. 2134 van 26 November 1943.

**WOORDVERKLARING.**

1. Vir die toepassing van hierdie regulasies beteken „die Wet” die Wet op Vreemdelinge, 1937 (Wet No. 1 van 1937), en enige uitdrukking waaraan in en vir die toepassing van die Wet 'n betekenis geheg is, het, wanneer dit in hierdie regulasies gebruik word, dieselfde betekenis.

**IMMIGRANTEKEURRAAD.**

2. (1) Elke lid van die Raad beklee sy amp vir 'n tydperk van hoogstens twee jaar en sy aanstelling kan te eniger tyd gedurende daardie tydperk beëindig word.

(2) 'n Lid wie se ampstermyn verstryk het, kan weer aangestel word.

(3) Die besoldiging van elke lid wat nie in die voltydse diens van die Staat is nie, is R1,320 per jaar.

(4) Aan elke lid wat nie in die voltydse diens van die Staat is nie kan afwesighedsverlof op aanbeveling van die Voorsitter en met die goedkeuring van die Sekretaris van Immigrasie toegestaan word met dien verstande dat die lid sy volle besoldiging ontvang as hy oor 'n tydperk van twaalf maande nie van meer vergaderings afwesig was as wat gewoonlik gedurende 'n aaneenlopende tydperk van dertig dae gehou word nie of nie vir meer as vier-en-twintig werksdae nie vir die werk van die Raad beskikbaar was nie.

(5) Afgesien van die bywoning van vergaderings wat kragtens artikel *drie* (6) van die Wet belê word, kan die Voorsitter na goedgeken sodanige ander pligte as wat regstreeks in verband met die werksaamhede van die Raad staan, aan lede opdra.

THE ALIENS ACT, 1937.

**REGULATIONS.**

It is hereby notified that the State President has, under powers vested in him by section *eleven* of the Aliens Act, 1937 (Act No. 1 of 1937), as amended, been pleased to make the following regulations, in substitution for the regulations published under Government Notice No. 161, dated the 30th January, 1937, as amended by Government Notices No. 281, dated the 17th February, 1937, No. 466, dated the 17th March, 1938, No. 455, dated the 28th March, 1939, No. 1975, dated the 20th December, 1957, No. 1049, dated the 10th November, 1961, and No. 1483, dated the 14th September, 1962, and the regulations published under Government Notice No. 759, dated the 11th May, 1937, as amended by Government Notices No. 1030, dated the 16th June, 1938, and No. 2134, dated the 26th November, 1943.

**INTERPRETATION OF TERMS.**

1. For the purposes of these regulations “the Act” shall mean the Aliens Act, 1937 (Act No. 1 of 1937), and any expression to which a meaning has been assigned in and for the purpose of the Act shall, when used in these regulations, bear the same meaning.

**IMMIGRANTS SELECTION BOARD.**

2. (1) Each member of the Board shall hold office for a period not exceeding two years and his appointment may be terminated at any time during that period.

(2) A member whose term of office has expired shall be eligible for re-appointment.

(3) The remuneration of each member who is not in fulltime employ of the State, shall be R1,320 per year.

(4) Each member who is not in fulltime employ of the State may be granted leave of absence on the recommendation of the Chairman and with the approval of the Secretary for Immigration on the understanding that the member shall receive his full remuneration if, over a period of twelve months he has not been absent from more meetings than are normally held during a continuous period of thirty days or has for not more than twenty-four working days not been available for the work of the Board.

(5) Apart from attending meetings convened in terms of section *three* (6) of the Act, the Chairman may, in his discretion, assign to members such other duties as may be directly connected with the work of the Board.

AANSOEKFORMS EN PERMITTE.

3. (1) Elke vreemdeling wat die Republiek van Suid-Afrika of Suidwes-Afrika vir blywende vestiging wil binnekom, moet daarom aansoek doen by die Sekretaris van Immigrasie op 'n vorm wat wesenlik dieselfde is as die Eerste Bylae van hierdie regulasies.

(2) Die aansoek moet vergesel gaan van—

(a) drie identiese afdrucke van 'n foto van die gesig van die applikant, een van voor geneem, en drie in profiel geneem (almal ten tyde van die aansoek geneem) op dun papier, nie kleiner as 1½ duim vierkant nie, waarop die gelaatstrekke duidelik en korrek afgebeeld word, soos volg deur 'n verantwoordelike persoon gesertifiseer: „Gesertifiseer 'n juiste foto van mnr./mev./mej.....”.

\*(b) Die oorspronklike geboortesertifikaat van die applikant.

\*(c) (i) Indien getroud, die oorspronklike huweliks-sertifikaat.

\*(ii) Indien geskei, 'n gewaarmerkte afskrif van die egskedingsbevel.

\*(iii) Indien 'n wewenaar of weduwee die oorspronklike sterftesertifikaat van die afgestorwe eggenoot(-note).

(d) (i) 'n Mediese sertifikaat op 'n vorm wat wesenlik dieselfde is as die Tweede Bylae van hierdie regulasies.

(ii) X-straal en kliniese verslae oor die applikant se bors.

(Massa-radiografiese verslae word aanvaar.)

L.W.—Verslae onder (ii) is slegs nodig ten opsigte van persone wat agt jaar of ouer is.

(e) 'n Sertifikaat deur 'n polisiebeampte op 'n vorm wat wesenlik dieselfde is as die Derde Bylae van hierdie regulasies.

\*(f) Die oorspronklikes van hoogste opvoedkundige sertifikate of diplomas of graadsertifikate.

\*(g) Gewaarmerkte afskrifte van getuigskrifte van applikant se vorige en/of teenswoordige werkgewers ten opsigte van die applikant se bevoegdheid in sy ambagte of beroepe. Dit moet sy diens oor ten minste die afgelope vyf jaar dek.

\*(h) Sertifikate van goeie gedrag van applikant se teenswoordige werkgewer, of 'n predikant, of 'n geregtelike beampte, of 'n ander persoon van aansien.

(i) Dokumentêre bewyse van finansiële omstandighede.

(j) Indien reëlins reeds getref is vir indiensplasing in Suid-Afrika, 'n brief van die werkgewer in Suid-Afrika waarin die aard van die werk en die salaris wat aangebied word, vermeld word.

\*Indien hierdie dokumente nie in Engels, Nederlands of Vlaams is nie, moet gewaarmerkte vertalings in Engels ingedien word. In hierdie gevalle word die oorspronklike dokumente nie benodig nie.

OPMERKING:

(i) Dokumente (e), (f), (g), (h), (i) en (j) word nie ten opsigte van kinders onder die ouderdom van 16 jaar verlang nie.

(ii) Dokumente (g), (h) en (j) is net nodig ten opsigte van persone wat werk in Suid-Afrika sal aanvaar.

(iii) Dokument (i) is net nodig ten opsigte van persone wat hul eie besighede of praktyk wil begin of in Suid-Afrika wil afdreef.

4. 'n Aansoek wat ingevolge regulasie 3 van hierdie regulasies gedoen word, moet ingedien word by, of deur die pos gestuur word aan, 'n verteenwoordiger van die Republiek in die land of gebied waar die aansoeker werklik woonagtig is, of waar daar nie 'n sodanige verteenwoordiger is nie, aan die Sekretaris van Immigrasie, Pretoria. Indien die applikant toegelaat is om die Republiek of Suidwes-Afrika vir tydelike verblyf daarin binne te kom, en terwyl hy wettiglik daarin vertoef, moet sy aansoek regstreeks aan die Sekretaris van Immigrasie, Pretoria, gestuur word.

APPLICATION FORMS AND PERMITS.

3. (1) Any alien who wishes to enter the Republic of South Africa or South West Africa for permanent residence must apply therefor to the Secretary for Immigration on a form which is substantially in agreement with the First Annexure to these regulations.

(2) The application must be accompanied by—

(a) three identical copies of a full face photograph of the applicant and three taken in profile (all taken at the time of the application) on thin paper. Size not less than 1½ inches square on which the features are clearly and correctly depicted and certified as follows by a responsible person: “Certified a true photograph of Mr./Mrs./Miss .....”.

\*(b) The applicant's original birth certificate.

\*(c) (i) If married the original marriage certificate.

\*(ii) If divorced a certified copy of the decree of divorce.

\*(iii) If widowed, the original death certificate of the deceased spouse.

(d) (i) A medical certificate on a form which is substantially in agreement with the Second Annexure to these regulations.

(ii) X-ray and clinical reports of the applicant's chest.

(Mass radiography reports are acceptable.)

N.B.—Reports under (ii) are required only in respect of persons who are eight years of age and older.

(e) A certificate by a police official on a form which is substantially in agreement with the Third Annexure to these regulations.

\*(f) Originals of highest educational certificates or diplomas or degree certificates.

\*(g) Certified copies of testimonials from the applicant's previous and/or present employers, as to applicant's competency in his trades or occupations covering at least the last five years of service.

\*(h) Certificates of character from his present employer, or a minister of religion, or any judicial officer or a person of standing.

(i) Documentary proof of financial circumstances.

(j) If employment in South Africa has already been arranged, a letter from the employer in South Africa, stating the nature of the employment and the salary offered.

\*If these documents are not in English, Netherlands or Flemish, certified English translations must be submitted. In these cases the original documents are not required.

NOTE:

(i) Documents (e), (f), (g), (h), (i) and (j) are not required in respect of children under the age of 16 years.

(ii) Documents (g), (h) and (j) are required only in respect of persons who will take up employment in South Africa.

(iii) Document (i) is required only in respect of persons who intend opening their own businesses or practices or who intend retiring in South Africa.

4. An application made under regulation 3 of these regulations shall be delivered to or transmitted through the post to a representative of the Republic of South Africa in the country or territory where the applicant actually resides or, where there is no such representative, to the Secretary for Immigration, Pretoria. If the applicant has been permitted to enter the Republic or South West Africa for the purpose of temporary sojourn therein, and whilst he is legally sojourning therein, his application shall be transmitted direct to the Secretary for Immigration, Pretoria.

5. Die permit bedoel in artikel vier van die Wet moet wees op 'n vorm wat wesenlik dieselfde is as die Vierde Bylae van hierdie regulasies.

6. (1) Elke vreemdeling wat die Republiek of Suidwes-Afrika vir tydelike verblyf daarin wil binnekom, moet aan die Paspoortbeheerbeampte die werklike tydperk wat hy verlang om in die Republiek of Suidwes-Afrika te vertoef, meld en moet aan sodanige beampte die volgende verstrekk:—

- (a) Volledige besonderhede wat betref die redes daarvoor;
- (b) sodanige geloofsbriewe as wat hy besit ter staving van sy versoek;
- (c) 'n geldige paspoort of ander reisdokument waarvan die geldigheidsduur nie gedurende sodanige tydelike verblyf verstryk nie; en
- (d) indien die Paspoortbeheerbeampte dit nodig ag, 'n foto wat onlangs van die applikant geneem is.

(2) Enige aansoek om 'n tydelike permit bedoel in artikel vyf bis van die Wet moet skriftelik gedoen word op 'n vorm wat wesenlik dieselfde is as die Vyfde Bylae van hierdie regulasies.

(3) Die tydelike permit wat kragtens subartikel (1) van artikel vyf van die Wet uitgereik mag word, moet op 'n vorm wees wat wesenlik dieselfde is as die Sesde Bylae van hierdie regulasies. Die Paspoortbeheerbeampte kan, na goeddunke, van die houer van enige sodanige tydelike permit vereis om 'n bedrag van hoogstens tweehonderd rand (R200) as sekuriteit te deponeer vir die nakoming deur die houer van die voorwaardes in die tydelike permit vermeld, of om enige sekuriteit te stel wat die Paspoortbeheerbeampte voldoende ag vir die betaling van sodanige bedrag in plaas van sodanige deposito. Die deposito word terugbetaal slegs wanneer die vermeldde voorwaardes nagekom is en wanneer sodanige houer die Republiek of Suidwes-Afrika verlaat binne die tydperk waarvoor die permit uitgereik is.

7. Die bepalinge van die regulasies met betrekking tot die aanhouding en verwydering van persone, uitgevaardig kragtens die Wet tot Regeling van die Toelating van Persone tot de Unie, 1913, is *mutatis mutandis* van toepassing op 'n vreemdeling wat ingevolge die Wet aangehou word in afwagting van verwydering, of wat verwyder word.

#### VANSVERANDERING.

8. Enige persoon, hieronder die applikant genoem, wat 'n nuwe van ooreenkomstig die bepalinge van artikel nege van die Wet wil aanneem, moet die kennisgewing wat by paragraaf (a) van subartikel (2) van daardie artikel vereis word, in die vorm voorgeskryf in die Sewende Bylae van hierdie regulasie, vir die rekening publiseer, en moet daarna na verloop van dertig dae maar binne negentig dae vanaf die datum waarop die finale kennisgewing in die *Staatskoerant* of daaglikse nuusblad, na gelang van die geval, verskyn; by die Sekretaris van Binnelandse Sake, in die vorm voorgeskryf in die Agste Bylae van hierdie regulasies, aansoek doen om die Staatspresident se magtiging soos vermeld in genoemde artikel, en moet die verklaringe in die aansoek gedoen deur middel van 'n beëdigde verklaring bevestig: Met dien verstande dat die Sekretaris van Binnelandse Sake na aanvoering van voldoende rede, na goeddunke 'n aansoek mag aanneem van 'n applikant wat in alle opsigte aan die voorgeskrewe prosedure voldoen het maar versuim het om sy aansoek binne die voorgeskrewe tydperk van negentig dae vanaf die datum van die finale kennisgewing in die *Staatskoerant* of in die daaglikse nuusblad, na gelang van die geval, in te dien.

9. Die applikant moet sy aansoek vergesel laat gaan van die landdros se aanwysing van die nuusblaai waarin bovermelde kennisgewing gepubliseer is en van een volledige blad, insluitende die opskrif en datum, van die betrokke uitgawes van die *Staatskoerante* en die twee daaglikse nuusblaai waarin die voorgeskrewe kennisgewing gepubliseer is.

5. The permit referred to in section four of the Act shall be on a form which is substantially in agreement with the Fourth Annexure to these regulations.

6. (1) Any alien who desires to enter the Republic or South West Africa for temporary sojourn therein shall state to the Passport Control Officer the actual period he desires to remain in the Republic or South West Africa and shall furnish to such officer—

- (a) full particulars as to the reason therefor;
- (b) such credentials as he possesses to support his request;
- (c) a valid passport or other travel document the period of validity of which does not expire during such temporary sojourn; and
- (d) if the Passport Control Officer deems it necessary a recent photograph of the applicant.

(2) Any application for a temporary permit referred to in section five bis of the Act must be made in writing on a form which is substantially in agreement with the Fifth Annexure to these regulations.

(3) The temporary permit which may be issued in terms of sub-section (1) of section five of the Act, shall be on a form which is substantially in agreement with the Sixth Annexure to these regulations. The Passport Control Officer may, in his discretion, require the holder of any such temporary permit to deposit a sum not exceeding two hundred rand (R200) as security for the observance by the holder of the conditions mentioned in the temporary permit or to furnish any security which the Passport Control Officer deems sufficient, for the payment of such sum in lieu of such deposit. The deposit shall be refunded only upon fulfilment of the said conditions and upon such holder leaving the Republic or South West Africa within the period for which the permit is issued.

7. The provisions of the regulations in respect of the detention and removal of persons made in terms of the Admission of Persons to the Union Regulation Act, 1913, are *mutatis mutandis* applicable to an alien who, in terms of the Act, is being detained pending removal or is being removed.

#### CHANGE OF SURNAME.

8. Any person, hereinafter referred to as the applicant, who desires to assume a new surname in accordance with the provisions of section nine of the Act, shall at his own expense publish the notice, required by paragraph (a) of sub-section (2) of that section, in the form prescribed in the Seventh Annexure to these regulations, and thereafter shall, after a lapse of thirty days but within ninety days of the date of publication of the final notice in the *Gazette* or in the daily newspaper, as the case may be, apply to the Secretary for the Interior in the form prescribed in the Eighth Annexure to these regulations for the State President's authorisation mentioned in the said section, and shall confirm by affidavit the statements made in the application: Provided that the Secretary for the Interior may at his discretion, upon good cause shown, accept an application from an applicant who has complied with the prescribed procedure in all respects but has failed to submit his application within the prescribed period of ninety days of the date of the final notice in the *Gazette* or in the daily newspaper, as the case may be.

9. The applicant shall attach to his application the magistrate's designation of the newspapers in which the aforesaid notice was published and one copy of the full page including the title and dated heading thereof of each issue of the *Gazette* and of the two daily newspapers in which the prescribed notice was published.

10. Die applikant moet, wanneer hy aansoek doen, die som van twaalf rand (R12) aan die Sekretaris van Binnelandse Sake betaal en, as die aansoek geweier word, word daardie bedrag aan die applikant terugbetaal. Die bedrag van twaalf rand sluit die aansoeke van die applikant, sy vrou en minderjarige kinders, as daar is, in.

11. Nadat die Staatspresident die applikant gemagtig het om die van waarom hy aansoek gedoen het, aan te neem, moet die Sekretaris van Binnelandse Sake die applikant binne een maand vanaf die datum van sodanige magtiging dienooreenkomstig in kennis stel en sodanige magtiging in die *Staatskoerant* publiseer en eenmaal in die twee nuusblaaië genoem in regulasie 9 van hierdie regulasies.

10. The applicant shall pay to the Secretary for the Interior at the time of application the sum of twelve rand (R12) and if the application is refused that sum shall be refunded to the applicant. The fee of twelve rand shall include the applications of the applicant, his wife and minor children, if any.

11. After the State President has authorised the applicant to assume the surname applied for, the Secretary for the Interior shall, within one month of the date of such authority, notify the applicant accordingly and publish such authority in the *Gazette* and once in the two newspapers mentioned in regulation nine of these regulations.
