GASGEWERE VAN ·22- EN GROTER KALIBER.—  
VERKLARING TOT VUURWAPENS KRAG-  
TENS ARTIKEL *SES-EN-DERTIG* VAN DIE

CUSTOMS ACT, No. 55 OF 1955.—APPOINTMENT  
OF LANDING PLACES, TRANSIT SHEDS,  
ENTRANCES AND EXITS.

It is notified for general information that the Commissioner of Customs and Excise, acting under the powers conferred on him by section *seventeen* of the Customs Act, No. 55 of 1955, hereby—

- (1) withdraws the appointment of the Gardiner Street Ferry Jetty, Durban, as a place for landing, loading and embarkation; and
- (2) amends Schedule No. 1 of Government Notice No. 230 of the 17th February, 1956, as amended, by the deletion of the expression "For persons only: Gardiner Street Ferry Jetty." where it appears under the heading "*Durban*."

NOTE.—The effect of this notice is to cancel the appointment of the above-quoted place as a place for landing, loading and embarkation.

GAS RIFLES OF ·22 AND LARGER CALIBRE.—  
DECLARATION AS ARMS IN TERMS OF  
SECTION *THIRTY-SIX* OF THE ARMS AND  
AMMUNITION ACT, 1937.

By virtue of the powers vested in me by section *thirty-six* of the Arms and Ammunition Act, 1937 (Act No. 28 of 1937), I, FRANCOIS CHRISTIAAN ERASMUS, Minister of Justice of the Union of South Africa, hereby declare all gas rifles of ·22 and larger calibre which are capable of being used for propelling any substance or article, to be arms for the purposes of the said Act, within the Union of South Africa.
