# Appropriation Act 1 of 2004 <br> (GG 3224) 

came into force on date of publication: 24 June 2004

## ACT

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2005.
(Signed by the President on 16 June 2004)

BE IT ENACTED by the Parliament of the Republic of Namibia, as follows:

## Appropriation of amounts of money for financial requirements of the State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2005 as a charge to the State Revenue Fund.

## Short title

2. This Act is called the Appropriation Act, 2004.
