## **Appropriation Act 11 of 1991**

(GG 227)

came into force on date of publication: 27 June 1991

### **ACT**

**To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 1992.**

*(Signed by the President on 24 June 1991)*

---

BE IT ENACTED by the National Assembly of the Republic of Namibia, as follows:-

#### **Appropriation of amounts of money for financial requirements of State**

1. Subject to the provisions of the State Finance Act, 1982 (Act 1 of 1982), there are hereby appropriated for the financial requirements of the State during the financial year ending 31 March 1992, as a charge to the State Revenue Fund, the amounts of money shown in the Schedule.

#### **Short title**

2. This Act shall be called the Appropriation Act, 1991.
